


When eBay manages payments, sellers have one place to manage their transactions.

1. Connect a Payoneer Account

Moving forward, you'll get paid via a Payoneer account. You have the option to link an existing Payoneer account, or create a new one.

Note: Seller payouts and charges are processed in US dollars (USD).

2. Sync eBay and Payoneer profiles

After you register or link your existing Payoneer account, we'll pull in your details from Payoneer to sync your eBay profile

3. Add a credit card or debit card for seller charges selling costs

We need a card on file in case you have outstanding amounts owed to eBay and your funds are insufficient.

4. Submit registration info

Your details will be verified and we'll contact you before you are activated on managed payments.

By proceeding, you agree that any information you have provided or will provide to Payoneer, including personal details such as your name, ID number and contact details, will be shared with eBay as an independent controller of such data. 



No transfers needed

Simpler fees

eBay charges one updated final value fee when your item sells. The final value fee consists of a category-based percentage of the total amount of the sale, plus a fixed fee per order, with no third-party payments processing fees. Most sellers can expect to see overall savings.* See details.
